1779 Dobbs to Craven Co. NC...

[David Webb](#) - Shadrack Mercer 7 December 1779 Dobbs County, NC This indenture made 7 Dec. 1779 between [David Webb](#) of Dobbs Co., NC of the first part and Shadrack Mercer (same) witnesseth that said [David Webb](#) in consideration of 150 pounds current money of NC to me in had paid before delivery by Shadrack Mercer, receipt acknowledged have granted and sold unto sd. Shadrack Mercer his heirs and assigns forever that plantation which [David Webb](#) now lives on [S. side of Little Contentney Creek and on N. side of Thompsons Swamp](#), bounded by Capt. William Speight's line and runs down Speight's line to run of [Thompson's Swamp](#) to marked trees between [David Webb](#) and [James Webb](#) near John Wards corner which is part of a tract granted by deed from Earl Granville to Elias Bergm dated 7 Jan. 1763 and from Elias conveyed by deed to Thomas Walston dated 14 Oct. 1766 and from Walston to [Aaron Webb](#) 8 Feb. 1773 and by

decease of **Aaron Webb** descending to **David Webb**, present seller and **eldest son of Aaron Webb**. Land content estimation of 60 acres with all rights to same belonging to Shadrack Mercer, his heirs and assigns forever and Sd **Webb** warrants and defends title. STATE OF NORTH-CAROLINA.

KNOW all men by these presents, that we *James Webb*
& *James Barney*
are held and firmly bound unto his Excellency *Joseph Franklin*
Esquire; Governor, Captain General and Commander in Chief, in and over
the said State, in the sum of five hundred pounds current money to be paid to
the said Governor, his successors or assigns. To the which payment well
and truly to be made, we bind ourselves, our heirs, executors, and adminis-
trators, jointly and severally, firmly by these presents. Sealed with our seals,
and dated this *2nd* day of *May* - A. D. 1821

THE Condition of the above Obligation is such, that whereas the above
bounden *James Webb*
hath made application for a License for a Marriage, intended to be had and
solemnized between him and *Sophia Bell*
of the County aforesaid. Now in case it shall not appear at any time here-
after, that there is any lawful cause to obstruct the said Marriage, then the
above obligation to be void, otherwise to remain in full force and virtue.
